## **Supplier Posting Requirements**

Upon logging in to your icix site, select the "My Members" tab. Make sure the "Members" radio button is selected, type ARYZTA in the search field and then click "Search." All of the ARYZTA North America locations should be listed. Click on the "Add" button for each location to add them to your Company Member List. Once this is complete, you should see the ARYZTA compliance thermometer located on the right-hand side of your icix home page. Click on the "Become Compliant" button, then on each of the requirements to comply. If you do not see the ARYZTA compliance thermometer, please click on the "Refresh" link under the compliance summary box.
